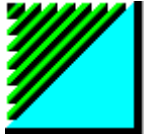
Jeff,


To Whom It May Concern:
